Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Cukai Jualan (Kadar Cukai) (Pindaan) 2018**.

(2) Perintah ini mula berkuat kuasa pada 6 September 2018.

SALES TAX ACT 2018

SALES TAX (RATES OF TAX) (AMENDMENT) ORDER 2018

IN exercise of the powers conferred by subsection 10(2) of the Sales Tax Act 2018 [*Act 806*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Sales Tax (Rates of Tax) (Amendment) Order 2018**.

(2) This Order comes into operation on 6 September 2018.

Amendment of First Schedule

2. The Sales Tax (Rates of Tax) Order 2018 [*P.U. (A) 221/2018*] is amended in the First Schedule—

(a) in relation to heading 03.05—

(i) in column (3), after subheading 0305.49.00 00 and the particulars relating to it, by deleting the words “- Fish, salted but not dried or smoked and fish in brine, other than edible fish offal:”; and

(ii) by deleting subheadings 0305.61.00 00, 0305.62.00 00, 0305.64.00 00, 0305.69, 0305.69.10 00 and 0305.69.90 00 and the particulars relating to them;

(b) by inserting after heading 16.04 and the particulars relating to it the following heading and particulars:
